Dear Ms. Schmit:

On March 10, 2010, you submitted a Freedom of Information Act (FOIA) request with the BIA, Office of Justice Services seeking:

“The purpose of this request is to gather documentation of Law Enforcement Service Level Commissions/Cards (SLAC’s, SLEC’s, and SLIC’s) Memorandum of Understanding (MOU’s) that includes the Hopland Indian Rancheria of California and the Colorado River Indian Tribes agreements with both Arizona and California:

1. Any MOU between Hopland Indian Rancheria and Colorado River Indian Tribe and the BIA related to SLEC agreements.
2. Any record describing federal supervision or oversight by the BIA of the Colorado River Indian Tribe “Ranger” program. Tribal resolution or any other evidence of authorization of these officers.”

The BIA, Office of Justice Services FOIA Office received the request on March 25, 2010. We assigned your request **FOIA control # 2010-00768** for processing. Please cite this number in all correspondence with the Department regarding this portion of your request.

We have classified your request as an “other-use” request, meaning that you are entitled to up to 2 hours of search time and 100 pages of photocopies before being charged for the processing of your request. Additionally, the Department of the Interior does not bill requesters for FOIA fees incurred in processing “other-use” requests when their fees do not exceed \$30.00. We have determined that your request does not meet the minimum threshold to charge you fees for processing, therefore, the document will be released to you free of charge.

With respect to your first request for the MOU between Hopland Indian Rancheria and Colorado River Indian Tribe and the BIA related to SLEC agreements, we have identified 1 document (totaling 27 pages), which is responsive to this request. These responsive documents are being released to you.

With respect to your second request, the Bureau of Indian Affairs, Department of the Interior, does not have an agreement in place to oversee/supervise the Colorado River Indian Tribes "Ranger" program. The "Ranger" program is supervised by the Colorado River Indian Tribal Chairman's office. In accordance with the Department of Interior's FOIA regulations (43 CFR 2.22(b)(2)), we are referring this letter to the respective department for a direct response to you. I have consulted with Shari Mauney, Attorney-Advisor with the Office of the Solicitor, in reaching this decision.

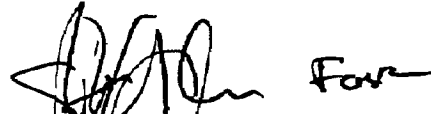

Dear Special Agent Mc Donall:

There is a heighten awareness and concern of the plubic in California over the development of Federal Peace Officers on Indian Reservations. The concerns are due to a lack of knowledge over the scope or limits of authority of these Federal Peace Officers.

We write to request documents pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552 *et seq.*, and pursuant to the Department of the Interior FOIA regulations, 43 C.F.R. § 2.11-2.20.

The purpose of this request is to gather documentation of Law Enforcement Service Level Commissions/Cards (SLAC's, SLEC's, and SLIC's) Memorandum of Understanding (MOU's) that includes the Hopland Indian Rancheria of California and the Colorado River Indian Tribes agreements with both Arizona and California:

- 1 Any MOU between Hopland Indian Rancheria and Colorado River Indain Tribe and the BIA related to SLEC agreements.
- 2 Any record describing federal supervision or oversight by the BIA of the Colorado River Indian Tribe "Ranger" program. Tribal resolution or any other evidence of authorization of these officers.

For any documents or portions thereof that are determined to be exempt from disclosure, we request that you state with specificity the legal and factual grounds for withholding documents or portions of documents. 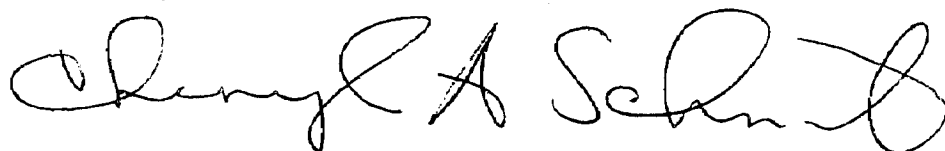
