

IT IS HEREBY STIPULATED by and between the COUNTY OF MADERA, a political 1 subdivision of the State of California; the BOARD OF SUPERVISORS OF THE COUNTY OF 2 MADERA; THOMAS P. KIDWELL, County of Madera Tax Assessor; TRACY DESMOND 3 4 KENNEDY, County of Madera Treasurer/Tax Collector; RAYBURN BEACH, County of Madera Planning Director; the COUNTY OF MADERA PLANNING DEPARTMENT 5 (collectively, "County"), and the PICAYUNE RANCHERIA OF THE CHUKCHANSI 6 7 INDIANS, a federally recognized Indian Tribe ("Tribe") that the above-entitled action has been settled pursuant to the terms of the written Settlement Agreement and Stipulation to Jurisdiction 8 ("Agreement"), attached hereto as Exhibit A and incorporated by reference. 9

10By the terms of the Agreement, these Stipulating Parties (hereafter, "Stipulating Parties")11consisting of the County and the Tribe, along with settling parties, Chukchansi Economic12Development Agency ("CEDA"), the Yosemite Unified School District ("Schools"), and13McCarthy Building Companies, Inc. ("McCarthy"), have contracted and agreed to resolve all14pending disputes under the terms and provisions set forth in Exhibit A, which terms include15various dispute resolution provisions as set forth therein. Pursuant to those dispute resolution16provisions:

17 IT IS HEREBY STIPULATED that the jurisdiction of United States District Court for
18 the Northern District of California, as currently in place over all parties to the instant action, shall
19 continue for purposes of determining the application, interpretation, and enforcement of the
20 Agreement attached hereto as Exhibit A.

These Stipulating Parties further each stipulate, acknowledge, and agree that the sovereign immunity of the Tribe and CEDA shall be expressly waived for purposes of any legal action or proceedings for purposes of determining the application, interpretation, or enforcement of the Agreement attached as Exhibit A.

These Stipulating Parties further stipulate, agree, and request that the continuing jurisdiction of this Court shall apply to further actions or legal proceedings regarding the application, interpretation, and enforcement of the Memorandum of Understanding executed by the Tribe and the County concurrently with the Settlement Agreement, attached hereto as
