Dear Mr. Leonard:

Please find enclosed a copy of an agenda for the on-the-record Technical Assistance (TA) meeting scheduled for Wednesday, April 24, 2019, at the Department of the Interior (Department). We will hold the meeting from 10 am to 1 pm in the North Penthouse of the Department's Main Interior Building (MIB), located at 1849 C Street, NW, in Washington, DC. All guests will need to enter on the C Street (south side of the MIB) and have a government-issued photo identification. The purpose of this meeting is to provide TA on the Department's Proposed Finding (PF) regarding the petition of the Southern Sierra Miwuk Nation (SSM, Petitioner #82).

The Office of Federal Acknowledgment (OFA) arranged the questions that you submitted to create an agenda that will facilitate the flow of discussion. OFA did not include some of these questions because they were outside of the scope of discussion as set forth in OFA's longstanding published guidelines for formal TA meetings (Guidelines), attached with this letter and available online at:

In accordance with the Guidelines, the enclosed agenda shows the questions submitted that fall within the discussion parameters, and an order for addressing them. The moderator will allow follow-up questions to agenda items as time and the flow of discussion permits. If you raise an issue that is fully discussed in the PF, OFA may refer you to the PF rather than repeat this material in the meeting.

The purpose of the meeting is for OFA to provide on-the-record TA to the petitioner and other interested parties and further explain the reasoning, analyses, and factual bases of the PF. The upcoming meeting is not an adjudicatory hearing, but a TA meeting. OFA will not discuss issues beyond the scope of the PF, such as the legality of the regulations or the deliberative process that went into issuing of the decision. The moderator will be responsible for seeing that the meeting is conducted in a fair, impartial, and professional manner, that all questions are addressed, and that the meeting proceeds in a timely way. OFA reserves the right to make minor modifications to this agenda if deemed appropriate to achieving the goals of the on-the-record meeting.

OFA will ensure that copies of the PF and <u>Federal Register</u> notice are available for reference. At this meeting, OFA will not provide or discuss documents in its files covered under the Privacy Act or under a Freedom of Information Act (FOIA) exemption, except as provided in the formal meeting guidelines. Documents used for the PF are available to the petitioner at any time during

the comment period, even after this meeting, and they may be obtained by submitting a standard FOIA request to this office. Petitioners and interested parties may also obtain informal TA from OFA through scheduled teleconference, letter writing, or—time permitting—informal TA meetings.

On the day of the meeting, please enter the Department's MiB at the "C" Street first floor entrance. Again, please have a government-issued photo identification, such as a California driver's license or a US passport. The Department's security will deny entrance to individuals without appropriate identification. You will have to check in with Security and obtain a visitor's badge. When all individuals have arrived, OFA will provide an escort to the North Penthouse, Seventh Floor.
