Dear Information Officer:

Pursuant to my rights under the California Public Records Act (Government Code Section 6250 et seq.) and the California Constitution, as amended by passage of Proposition 59 on November 2, 2004, *Stand Up For California* is writing to request records, which I understand to be in the possession of your City.


The Sacramento Bee has published incident reports and service calls to the Sacramento Police related to the Casino Royale. (*See* – attached) However, this publication does not appear to be up-to-date or thorough. This request is for a complete report on the number of service calls and incident reports directly related to the Casino Royale Card Club since its opening in 2008 - to date. The card room is located at 2052 Auburn Boulevard, Sacramento, CA. 95821. This is timely information as the City of Sacramento is considering a revamping of the City Card Room Ordinance which will directly affect the staffing of your department and your duty to protect the safety of the public.

I ask for a determination on this request within 10 days for your receipt of it, and an even earlier reply if you can make that determination without having to review the records in question. If you nonetheless determine that the requested records are subject to a still-valid exemption, I would further request that: (1) you exercise your discretion to disclose some or all of the records notwithstanding the exemption, and (2) that, with respect to records containing both exempt and nonexempt content you redact that exempt content and disclose the rest.

Finally, should you deny part or this entire request; you are required to provide a written response describing the legal authority or authorities on which you reply. I ask that you notify

me of any duplication costs exceeding \$50.00, so that I may decide which records I want copied.
If possible I request that the information be sent electronically.
