To Whom It May Concern:

This letter is to verify that the pages from the Progress report to the Governor and the Legislature by the State Advisory Commission on Indian Affairs (Senate bill No. 1007) on Indians in rural and reservation areas, published by the State of California (dated February 1966) that relate to the Shingle Springs Rancheria in El Dorado County are as follows:

Pg. 54: Appendix A: Table 2, Indian population for California Counties: 1960, 1950, 1940, listing under El Dorado County: "1960 Total population: 29,390 – 1960 Indian population: 88 – 1960 change over previous census (percent): -20.0 ; 1950 Total population: 16,207 – 1950 Indian population: 110 – 1950 change over previous census (percent):29.4 ; 1940 Total population: 13,229 – 1940 Indian population: 85."

Pg. 55: Appendix A: Table 3, Percentage change in Indian population by county groups 1950, 1960. listing under Rural counties under El Dorado "1960: -20.0 ; 1950: 29.4."

Pg. 56: Appendix A: Table 4, California reservations, population and land: 1962, 1963 listing under Shi[n]gle Springs – Me-Wuk – Estimated population June 30, 1962: Total: 5; Within units: --; Adjacent units: 5 – Land areas (acres) reported June 30, 1963: Tribal land: 240.

Pg. 58: Appendix A: Table 5, California reservations ranked by total population: Listing under Shingle Springs: "Total population: 5 ; Within unites: 0 ; Adjacent to units: 5 ; Area: 240 ; Reservations: Shingle Springs."

Pg. 90: Appendix C: "The majority of the 16 listed reservations, not visited by FTO representatives, must of necessity be placed in the "unknown" category and recommendations should be made by area officials. The 4 categories are separately listed below: ... Category 1 (Recommended): Reservation--Shingle Springs—Estimated total cost for program: \$6,000 ... It is considered that programs on the above listed reservations can be readily justified."

Pg. 93: Appendix C: California reservations surveyed by P.H.S. for water and sanitation facilities: listed under: Number 31: Shingle Springs – Date surveyed (1963) -- ; Surveyed by: -- ; Total houses surveyed: 1 ; Total persons housed: -- ; Adequate housing: -- ; Renovate: Number of houses: 1 ; Average estimated

Pg. 94: Appendix C: Note that the Shingle Springs Reservation is not listed in the summary of Indian Rancherias included in termination act. Those listed are: No assistance needed: Alexander Valley, Buena Vista, Cache Creek, Chicken Ranch, Lytton, Mark West, Mooretown, Paskenta, Potter Valley, Redding, Redwood Valley, Ruffeys, Strawberry Valley, and Table Bluff; No assistance requested: Middleton, Montgomery Creek, Chico, Indian Ranch, and Nevada City; Assistance requested: Big Sandy, Blue Lake, Cold Springs, Elk Valley, Greenville, North Fork, Picayune, Quartz Valley, Rohnerville, Table Mountain, and Upper Lake; Projects under construction: Smith River, Big Valley, Cloverdale, Guidiville, Graton, Hopland, Pinoleville, Robinson, and Scotts Valley; Projects completed: Auburn and Wilton.

Pg. 101: California Indian Groups Environmental Sanitation Survey, prepared by D.D. Geller and R.P. Morfitt. Table 6: Summary of projects and estimated costs: County: El Dorado – Project locations: Shingle Springs – Estimated costs: \* [less than \$10,000].

Pg. 110: Appendix D: Note that Shingles Springs Reservation is not listed in Public Law 85-671—Aug. 18, 1958 [Introduction]: *Indian Rancherias, land distribution*: "Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the lands, including minerals, water rights and improvements located on the lands, and other assets of the following rancherias and reservations in the State of California shall be distributed in accordance with the provisions of this Act: Alexander Valley, Auburn, Big Sandy, Big Valley, Blue Lake, Buena Vista, Cache Creek, Chicken Ranch, Chico, Cloverdale, Cold Springs, Elk Valley, Guidiville, Graton, Greenville, Hopland, Indian Ranch, Lytton, Mark West, Middletown, Montgomery Creek, Mooretown, Nevada City, North Fork, Raskenta, Picayune, Pinolville, Potter Valley, Quartz Valley, Redding, Redwood Valley, Robinson, Rohnerville, Ruffeys, Scotts Valley, Smith River, Strawberry Valley, Table Bluff, Table Mountain, Upper Lake, Wilton."
