The purpose of this letter is to respond to your Freedom of Information Act (FOIA) request dated April 12, 2018. This FOIA has been assigned Control number FOIA BIA-2018-01046; please refer to this control number when referencing this request. Your request included the following information:

• A copy of the most recent Quarterly Report Fee to Trust Applications cited in the Indian Affairs Directives Transmittal Sheet #52 of the Indian Affairs Manual. Indian Affairs Directive Transmittal Sheet #52 IAM 12, Release #10-24, 6-24-10 which included information in the Indian Affairs Manual, Part 52 Chapter 12 page 1-3. On page 3 Section D is the info on the Quarterly Reports.

In response to your request, the Bureau of Indian Affairs, Pacific Regional office, has enclosed sixty-five (65) pages of documents responsive to your request, which is being released to you in its entirety.

We do not bill requesters for FOIA processing fees when their fees are less than \$50.00, because the cost of collection would be greater than the fee collected. See -43 C.F.R. \S 2.37(g). Therefore, there is no billable fee for the processing of this request.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of FOIA. See U.S.C. §552(c) (2006) & Supp. IV (2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
