## Memorandum

To: Chief, Branch of Tribal Relations

Subject: Organizational Status of Federally Recognized Indian Entities1/

I have reviewed the organizational structures of the Indian entities eligible for Federal services and have classified them into three (3) categories. The three categories reflect the following totals.

1. Officially Approved Indian Organizations Pursuant to Federal Statutory Authority (Indian Reorganization Act; Oklahoma Indian Welfare Act; and Alaska Native Act)

In the Lower Forty-Eight and Alaska, a total of  $\frac{4}{272}$  Indian entities have formally approved organic documents as defined in Categories 1 and 2.

Combining all three categories, we recognize that 49<sup>5</sup> Indian entities in the United States, including Alaska, are eligible for Bureau of Indian Affairs assistance.
