Defendant YUBA COUNTY (the "County") prepare the record of proceedings, if any, before the YUBA COUNTY BOARD OF SUPERVISORS concerning actions taken to develop/grade/

construct in the Raceway Property (Measure R Property) at any time from January 2017 to the present (the "Project").
