LAST WILL AND TESTAMENT

KNOW ALL MEN BY THESE PRESENTS:

of California, over the age of eighteen years, being of sound and disposing mind and memory and not acting under duress, menace, fraud, or the undue influence of any person whom over, do hereby make, publish and declare this to be my Last Will and Testament, in the manner following, that is to say:

FIRST: I revoke all other and former Wills and Codicils to Wills by me made at any time heretofore.

SECOND: I declare I am married and my husband's name is George W. Nelson and there are two children the issue of said marriage, to-wit: Andrew U. Nelson, deceased, leaving no issue; and Neomia N. Nelson, deceased, a single person, leaving no issue. I further declare I had one child the Issue of my previous marriage, to-wit: Serena Bradlock, a daughter, deceased, leaving no issue.

THIRD: I devise and bequeath all of my estate and effects of whatsoever nature and wheresoever situated. be it real, personal or mixed, of which I may be entitled or which I may have power to dispose of at my decease, unto my husband, George W. Nelson, absolutely; provided, however, that my said husband shall have survived me by 90 days, (excluding the date of my death in such computation), and if my said husband shall die within said 90 days after my death, he shall be deemed to have predeceased me for all purposes under this Will. In the event my said husband shall predecease me or die within 90 days after my death, then I hereby devise and bequeath all of my estate and effects of whatsoever nature and wheresoever situated, be it real, personal or mixed, of which I may be entitled or which I may have power to dispose of at my decease, unto Russell J. King, absolutely.

FOURTH: I expressly omit leaving anything, and have

purposely made no provision for any other person not herein expressly provided for, whether claiming to be an heir of mine or not, and if any person, whether a bene-iclary under this Will or not mentioned herein, shall claim to be an heir, contest this Will or object to any of the provisions hereof, I give to such person so dalming, or contesting, of objecting the sum of One Dollar, (\$1.00), and no more, in lieu of the provisions which I have made or which I might have made herein for such person so claiming, or contesting, or objecting.

FIFTH; I nominate and request the Court to appoint Samuel R. Friedman, Executor of this my Last Will and Testament, to be permitted to serve in such capacity without any bond or undertaking whatsoever.
