Thank you for your recent letter regarding several suggestions to improve water availability in your area. I appreciate your keeping me informed of this situation.

In regards to the development of a new municipal water supply to the Old Barona Road Association, I'm aware both the County and LAFCO have previously provided you information on this suggestion, which is attached. However, in an effort to be of assistance, I'm taking the liberty of forwarding your letter to Ms. Maureen Stapleton, General Manager of the County Water Authority, so that she has an opportunity to review your letter and respond.

In addition, since you are suggesting that the Barona Tribe should enter into a ground water conservation agreement during the drought season, I'm taking the liberty of forwarding your letter to Chairwoman Rhonda Welch-Scalco of the Barona Band of Mission Indians so that she is personally aware of your correspondence. I'm sure she would appreciate the opportunity to respond to your suggestion.

Finally, in an effort to make sure you are fully informed on the Special Distribution Fund process, I am forwarding your letter to Mr. Walt Ekard, Chief Administrative Officer for the County, so that you can be provided information on the process for awarding grants to qualifying entities.
