As a former California Attorney General, I am familiar with the concerns you have raised about the efforts of the Colorado River Indian Tribe; however, as the current Treasurer of California, my responsibilities and authority no longer include any jurisdiction over the boundary issue.

The Governor's Office of Legal Affairs is responsible for overseeing the state's interests in tribal issues and in boundary matters such as these. For this reason, I have taken the liberty of forwarding your letter, along with a number of similar letters, to the Governor's Legal Affairs Secretary, Ms. Andrea Hoch.

I believe that Ms. Hoch and her staff will be best able to provide you with an up-to-date and accurate response to your concerns and your request for assistance.

Once again, thank you for taking time to write. I hope that you arrive at a satisfactory resolution before too long.



Thank you for contacting me with your concerns regarding the Colorado River Indian Tribes (CRIT). As always, I appreciate hearing from, and your patience while awaiting a response.

On February 22, 2008, I joined my colleague, Representative David Drier, in writing a letter to Attorney General Michael Mukasey with the United States Department of Justice. In this letter, we requested clarification from the Attorney General and asked that he address the differing interpretations of the rightful owner of lands that are west of the Colorado River and what entity has jurisdiction over those lands. It is my hope that their response will provide greater clarity to this matter and ensure fairness for all parties involved.

More importantly, in the conversations that my office has had with members of CRIT, they have assured me that they have no intent to remove homeowners from their property. In fact, they have shown interest in extending the leases for existing leasees in the area in dispute. I fully recognize that defining the boundaries of CRIT's reservation and addressing the legal status of these lands is of the utmost importance and I will be sure to keep your interests in mind as this matter moves forward.

Thank you for contacting me to express your opposition to the North Fork Rancheria of Mono Indians' proposed casino. I appreciate hearing from you and welcome the opportunity to respond.

I recognize your concerns about the proposed casino off Highway 99 in Madera County. You may be interested to know that Assistant Secretary of the Interior for Indian Affairs, Carl J. Artman, recently ordered that the Burcau of Indian Affairs and the North Fork Rancheria of Mono Indians consider an alternate site in North Fork.

Please know that I am deeply concerned about the proliferation of off-reservation gaming and the increasing attempts by out-of-State gaming interests to place gambling casinos near urban areas and major transit routes throughout California. I am also concerned about the ways in which casinos can impact traffic congestion, the environment, and water rights. I will be sure to keep your thoughts in mind as I continue to monitor this situation.
