**RE: Public Records Act Request**

Dear Bill Luna:

Pursuant to our rights under the California Public Records Act (Government Code Section 6250 et seq.) and the California Constitution, as amended by passage of Proposition 59 on November 2, 2004, Colorado River Residents for Justice is writing to request a copy of the following records, which we understand to be in the possession of your city:

- **Any and all Memos regarding the development and enactment of County policy of law enforcement along the Colorado River in the "disputed area".**
- **Any and all documents relating to County policy on taxation of residents along the Colorado River in the "disputed area" and that includes taxation of Indian owned properties and business sighted on land not in trust. (Only Trust land grants an exemption from taxation of private property.**
- **County Counsel memos drafting County policy in the "disputed area".**
- **Evidence that the County has carried out its own independent finding consistent with the requirements of the California Evidence Code Section 622.**

We ask for a determination on this request within 10 days of your receipt of it, and an even earlier reply if you can make that determination without having to review the record(s) in question. If you nonetheless determine that the requested records are subject to a still-valid exemption, we would further request that: (1) you exercise your discretion to disclose some or all of the records notwithstanding the exemption; and (2) that, with respect to records containing both exempt and non-exempt content; you redact the exempt content and disclose the rest.

Finally, should you deny part or this entire request; you are required to provide a written response describing the legal authority or authorities on which you rely.
