14 **DETAILS:**

15 On 04/13/11, about 1531 hours, I was dispatched to the Kampgrounds of America (KOA) located at 500  
16 Riviera Drive in Blythe, Ca., regarding a civil issue involving Robert Johnson and the Colorado River Indian  
17 Tribes (CRIT).

18 About 1548 hours, I arrived at the location and met with Robert Johnson, who told me he wanted CRIT  
19 removed from the Water Wheel Resort located at 29630 US Highway 95. Johnson gave me a Riverside  
20 County Property Tax Bill, which he claims is for the Water Wheel Resort (Parcel #806322011-5). Based on  
21 this tax bill, Johnson believes it proves his ownership of the property and wants CRIT to be charged with  
22 criminal trespassing.

23 Johnson also gave me a letter from the Governors Office. Johnson claims this letter was given to him  
24 anonymously by a CRIT member.

25 I told Johnson I could not remove CRIT from the property based solely on the paperwork provided.  
26 However, I did tell Johnson I would take the copies and document his statement.
