## H.R. \_\_\_\_\_, the Mono Lake Kutzadika<sup>a</sup> Tribe Recognition Act Rep. Paul Cook

## What is it?

This bill would grant the Mono Lake Kutzadika<sup>a</sup> Tribe federal recognition as a distinct Native American tribe.

A federally recognized tribe is an American Indian or Alaska Native tribal entity that is recognized as having a government-to-government relationship with the United States. Federally recognized tribes possess certain inherent rights of self-government and tribal sovereignty, and are entitled to receive certain federal benefits, services, and protections because of their special relationship with the United States.

## Who are the Mono Lake Kutzadika?

The Mono Lake Kutzadika<sup>a</sup> people are the indigenous people of the Mono Basin in east-central California and adjacent Nevada. Tribal members have lived near Mono Lake for time immemorial. They have functioned as a tribal community long before trappers, miners, and other white settlers came to California beginning in the early to mid-1800s. Despite significant challenges, the Mono Lake Kutzadika<sup>a</sup> Tribe has remained a distinct community, both politically and culturally. They have maintained their unique practices, including harvesting the alkali fly pupae from Mono Lake. This traditional food source for the tribe is also how the tribe derives its name: Kutzadika<sup>a</sup>, roughly translated, means "fly eaters."

The Mono Lake Kutzadika<sup>a</sup> Tribe has strongly and consistently advocated for preservation and conservation of Mono Lake, which is the center of their culture and history. The tribe has also worked with the U.S. Forest Service and National Park Service to honor their traditional gathering and hunting lands and unique customs. Local government and local divisions of the Forest Service and National Park Service recognize the Mono Lake Kutzadika<sup>a</sup> Tribe as a political entity to engage.
