**OPEN SESSION**

1. Call to Order and Pledge of Allegiance.

Chairman Shelton called the meeting to order at 1:31 p.m., and asked everyone to stand for the Pledge of Allegiance.

2. Roll Call of Commissioners.

Roll Call of Commissioners was taken with Chairman Shelton and Commissioners Cruz and Vuksich present.

1. Approval of Commission Meeting Minutes:

A. October 5, 2006

Upon motion of Chairman Shelton, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission approved the Commission meeting minutes for October 5, 2006.

B. October 19, 2006

Upon motion of Chairman Shelton, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission approved the Commission meeting minutes for October 19, 2006.

C. November 1 & 2, 2006

Upon motion of Chairman Shelton, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and

Vuksich voting yes, the Commission approved the Commission meeting minutes for November 1 and 2, 2006.

D. November 16, 2006

Upon motion of Chairman Shelton, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission approved the Commission meeting minutes for November 16, 2006.

4. Request to Remove Condition from State Gambling License:  
The Bicycle Casino

Deputy Director Ciau indicated that staff recommends that the Commission remove the condition that Mr. David Tait submit an application for a state gambling license by October 18, 2006. Upon motion of Commissioner Vuksich, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

5. Request to Place Conditions on State Gambling License:  
A. Club San Rafael  
B. Hollywood Park Casino  
C. The Bicycle Casino

Deputy Director Ciau indicated that staff recommends that the following condition be placed on the license for Items 5.A. Club San Rafael; 5.B. Hollywood Park Casino; and 5.C. The Bicycle Casino:

*The license is conditioned upon the local gambling ordinance coming into compliance with the Gambling Control Act (Business and Professions Code section 19860(a)(4)) within 12 months of issuance/renewal.*

Upon motion of Chairman Vuksich, seconded by Chairman Shelton and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

6. Requests for Additional Permanent Authorized Tables (Pursuant to California Code of Regulations, Title 4, section 12359):  
Lucky Buck Cardroom

Deputy Director Ciau indicated that staff recommends that the Commission approve the request for five additional tables for a total of ten tables authorized on the license for the Lucky Buck Cardroom. Upon motion of Chairman Shelton, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

7. Applications for Renewal of State Gambling License Including All Associated Applicants and Endorsees (Pursuant to Business and Professions Code section 19876):

A. California Grand Casino: Lamar Wilkinson, Sole Proprietor

Deputy Director Ciau indicated that staff recommends that the renewal license be approved for the remaining licensing period from February 1 through October 31, 2007, for California Grand Casino, Item 7.A., with the key employees listed in Attachment A to these minutes endorsed on the license.

David Fried, attorney for California Grand Casino, responded to concerns raised by Commissioner Vuksich concerning the local ordinance and whether it was in compliance to the Gambling Control Act.

Norm Pierce, Division of Gambling Control, indicated that the Division had reviewed the local ordinance and determined that it was in compliance and that the Division had communications with Mr. Fried informing him of the Division's determination.

Upon motion of Commissioner Vuksich, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

B. Cameo Club: Lewis & Lewis, Inc.

Deputy Director Ciau indicated that staff recommends that the Commission approve the renewal license for Cameo Club, Item 7.B., Lewis & Lewis, Inc., David Lewis President/Treasurer/Secretary and Natalie Lewis, Vice President, for the period of February 1, 2007 through January 31, 2008 with the following key employees: Jason Brisby, Eddie Dunn, David Lewis, Mike Nguyen and Sabah Toma. Staff also recommends that the license include the following condition:

*This license is conditioned upon the local gambling ordinance is in compliance with the Gambling Control Act (Business and Professions Code section 19860(a)(4)) within 12 months is issuance/renewal.*

Upon motion of Commissioner Cruz, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

C. Casino Club: Casino Poker Club, Inc.

Deputy Director Ciau indicated that staff recommends that the Commission approve the renewal license for Casino Club, Item 7.C., Ileana Harris, President/Treasurer/Secretary, for the period of February 1, 2007 through January 31, 2008 with the following key employees: Darlene Gevedon, Charles Leonard, and Phyla Sengxay. Staff also recommends that the license include the following condition:

*This license is conditioned upon the local gambling ordinance is in compliance with the Gambling Control Act (Business and Professions Code section 19860(a)(4)) within 12 months is issuance/renewal.*

Ileana Harris, Casino Club, presented comments concerning the condition placed on the license and indicated that she is working with the city to bring the ordinance into compliance with the Gambling Control Act.

Upon motion of Commissioner Vuksich, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

D. Gloria's Lounge and Casino: Gloria Gutierrez, Sole Proprietor

Deputy Director Ciau indicated that staff recommends that the Commission extend the renewal license for Gloria's Lounge and Casino, Item 5.D., for the period of February 1 through March 31, 2007, with the condition that: *the gambling establishment submit a corrected chart of accounts that identifies an asset account for the chip fund and the equity account.* In addition, staff recommends that the existing condition requiring that the chart of account be submitted, be removed. Upon motion of Chairman Shelton, seconded by Commissioner Cruz and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.

E. Klondike Casino: Leonard Marquez, Sole Proprietor

Director Ciau indicated that staff recommends that the Commission approve the renewal license for Klondike Casino, Item 7.E., for the period of February 1, 2007 through January 31, 2008 with the following condition:

*This license is conditioned upon the local gambling ordinance is in compliance with the Gambling Control Act (Business and Professions Code section 19860(a)(4)) within 12 months is issuance/renewal.*

Staff also recommends that the condition that annual table fees of \$167 be paid by September 1, 2006, be removed. Upon motion of Commissioner Cruz, seconded by Commissioner Vuksich and unanimously carried in a vote by roll call with Chairman Shelton and Commissioners Cruz and Vuksich voting yes, the Commission adopted the staff recommendation.
