NOTICE OF ASSUMPTION OF JURISDICTION UNDER 25 C.F.R. § 2.20(c) BY THE ASSISTANT SECRETARY - INDIAN AFFAIRS OVER AN APPEAL BY THE CAPAY VALLEY COALITION

On June 2, 2014, the Board of Indian Appeals (Board) received a notice of appeal from the Capay Valley Coalition (Appellant), through Donald B. Mooney, Esq. Appellant seeks review of an April 28, 2014, decision of the Pacific Regional Director, Bureau of Indian Affairs, to accept, in trust for the Yocha DeHe Wintun Nation, 853 acres of land, more or less, located within an unincorporated area of Yolo County, California.¹

On June 18, 2014, the Board received by memorandum dated June 17, 2014, a timely notice from the Assistant Secretary - Indian Affairs that he is assuming jurisdiction over this appeal, exercising his authority under 25 C.F.R. § 2.20(c) and 43 C.F.R. § 4.332(b). Pursuant to 25 C.F.R. § 2.20(c), the Board transfers this appeal to the Assistant Secretary, and pursuant to 43 C.F.R. § 4.332(b), all documents that have been filed with or issued by the Board concerning this appeal are being transmitted to the Assistant Secretary.
