Dear Mr. Morris:

As a member of the San Diego County Board of Supervisors with eleven Indian reservations in my Supervisorial District including Sycuan, I am writing to express my opposition to the Sycuan Band of the Kumeyaay Nation's proposed Fee to Trust application package, which seeks to take an additional 1,966 acres into Federal trust. This proposal represents the largest Fee to Trust application in the history of San Diego County.

I share the County of San Diego's concerns that the Environmental Assessment (EA) is of poor quality, and that NEPA only looks at one very limited set of development projects based on statements Sycuan has made. The EA fails to look at the possible resort and casino-related projects for which land of this volume could be used by the Tribe after the land is put into trust. A full Environmental Impact Statement (EIS) should be prepared. A project of this scope and undertaking justifies a more detailed evaluation of the environmental consequences and alternatives than is provided in the EA.

San Diego County would lose land use authority and the ability to enforce its environmental and zoning laws if this land is placed into Trust. The Sycuan tribe has stated that they are planning to utilize the land described in this application for a recreational vehicle park, pow-wow grounds, an equestrian center, a pavilion, and approximately 50 houses for tribal members. If the tribe has no intention of expanding gaming operations onto the 1,966 acres, then they should process the proposed projects through the County's land use process which is in place for developing land in the unincorporated area.

In addition, Sycuan's application to place additional property into trust would remove 30 parcels from the tax rolls in San Diego County. Using the most recent assessment, this would mean a loss of \$856,735.60 annually in property taxes. Similarly, this action would also result in a loss of sales tax and revenue for all government entities and special districts from this property. Lastly, the County would lose the additional

tax revenue from the future facilities and business that are developed on the 30 parcels.
